# WHY THIS ALERT

Thank you for spending a few minutes for consulting this session of our website. Your privacy is very important to APIMED - The Mediterranean Beekeepers Federation and to protect it as best as we can, we offer you these notes in which you will find recommendations on the type of information we collect online and on the various possibilities that you have to participate in the gathering and the usage of such information on the website.

This notice sheet it is based also on clause 13 of the Law Decree N. 196/2001 of the Code regarding the topic of the protection of personal data for all the users of the Web services of APIMED - The Mediterranean Beekeepers Federation, accessible on-line at this address http:// www.fedapimed.com, directing to the initial page of the official website of APIMED - The Mediterranean Beekeepers Federation.

This notice is provided only for the http://www.fedapimed.com, owned by APIMED - The Mediterranean Beekeepers Federation and its provision doesn't involve other websites that the users could access by links.

This notice is also based upon the Recommendation n.2/2001 that the European authority for the protection of personal data - reunited in the

Group formed by the clause 29 of the European Directive N.95/46/CE, - adopted the 17<sup>th</sup> of May 2001 to identify some minimal requirements for the on-line collection of personal data, and in particular way, time and nature of the information that the people appointed of the collection should provide to the users when they connect to web pages, independently for the reasons of the connection.

# THE ORGANIZATION APPOINETD FOR THE DATA TREATMENT

After the consultation of this website the data related to identified or identifiable people can be treated. The organisation appointed for the data collection is APIMED - The Mediterranean Beekeepers Federation, located in Via dell'Industria snc, Z. Ind. Sant'Eraclio - 06034 Foligno, P.IVA 91043020543. The responsible for the treatment is Vincenzo Panettieri (cod. Fisc. . PNTVCN50P01A225B) domiciled for the development of this task in Via dell'Industria snc, Z. Ind. Sant'Eraclio - 06034 Foligno.

# PLACE FOR THE TREATMENT OF THE DATA

The treatments related to the web services of this web site are executed at the above mentioned location of APIMED - The Mediterranean Beekeepers Federation, and they are edited only by technicians appointed for the treatment, or from other technicians appointed for temporary maintenance operations. The data collected from the web service are not used for communication or diffused. The personal data provided by the users that submit requests of sending of information (such as newsletter, etc. etc.) are used only with the aim of executing the service required. TYPES OF TREATED DATA

Web navigation data - ITC systems and the software procedures used in this web site acquire, during their normal functioning, some personal data whose transmission is implicit in the use of the web communication protocols.

We are talking about information that are not gathered to be associated with identified interested people, but that for their own nature could, passing through elaborations and associations with data held by others, allow to identify the users. In this category of data we consider the IP addresses or the names related to the domain of the computer that is used by the customers to connect to the web site, the addresses in notation URI (Uniform Resource Identifier) of the required resources, the time of the request, the method used for submitting the request to the server, the size of the file obtained as an answer, the numeric code indicating the state of the answer furnished by the server (correct, error, etc. etc.) and other parameters related to the operating system and to the IT environment of the user.

These data are used only to acquire anonymous statistical information on the use of the web site and to control its correct operation. The data could be used for the verification of the responsibility in the case of possible IT crimes damaging the web site and only upon request of the surveillance authorities in charge of the monitoring.

Data non voluntarily provided by the users

The discretionary, explicit and voluntary transmission of e-mails to the addresses listed in this web site involves the following acquisition of the address of the sender, necessary to answer to the requests, as well as to the possible other personal data that are inserted in the e-mail. COOKIES

Any personal data of the users are kept by the web site. We don't use cookies for the transmissions of information related to personal data, and we don't use persistent cookies of any type, or systems capable to trace the users. The use of session cookies (which are not memorized in a persistent way in the user pc and which disappear with the closure of the browser) is strictly limited to the transmission of identifying data related to the session (constituted by casual numbers generated by the server,) and they are necessary to permit the safe and efficient navigation of the site. The session cookies used in this web site avoid to draw upon other IT technics potentially detrimental for the privacy of the navigation by the users and they don't allow the acquisition of identifying personal data of the user.

### DISCRETIONARY PROVISION OF DATA

Beside what has been said about the navigation data, the user if free to provide personal data that are listed in the request files of APIMED - The Mediterranean Beekeepers Federation or otherwise stated in contacts to demand the shipping of information or other communications. The lack of the provision of the data could determine the impossibility in obtaining what is asked.

# PART EXPRESSELY RESERVED FOR UNDERAGES

Anyone younger than 18-years-old, without the previous consensus of the parents or of the person who is legally responsible for him/her, can send information to this web site without the above mentioned consensus, unless if this is allowed by the law in force. PROCEDURE OF TREATMENT

The personal data are treated with automated tools only for the time strictly necessary to achieve the scopes they have been gathered for. Specific safety measurements are applied to prevent the loss of the data, their illicit or not correct use and unauthorized accesses. RIGHTS OF THE PERSONS INVOLVED

The subjects to which the personal data refer to have the right in any moment to obtain the confirmation of the existence or non existence of their data and to find out their content and origin, to verify their exactness or to ask for their integration or updating, or the modification (clause 7 of the Law Decree n.196/2003). According to the same clause the person has the right to ask for the cancellation, the modification in anonymous form or the lock of the data treated in violation of the law, and to oppose in any case, for legitimate reasons, to their treatment.
